II. Activities of the Standing and Ad Hoc Committees

A. Committee on Committees & Positions, CHAIR: Becky Hayes

Additional Members: David Nicholson, Jody Clay-Warner

This committee is responsible for soliciting DWC volunteers to serve on both DWC and ASC committees. In January 2012, the committee sent a call for volunteers for 2013 – 2014 ASC committees. Susan Caringella and Molly Dragiewicz (former co-chairs of the Committee on Committees) assisted with the call and then volunteers were solicited three times via email through the DWC listserv and website. The committee compiled the list of DWC members willing to serve on ASC committees and forwarded it to the chair of the DWC, Amy D'Unger. Amy sent an email to Bob Agnew (ASC chair in 2013) on 2/8/12 with all the volunteers for DWC committees for 2013 – 2014. The committee will need to solicit more volunteers in the summer of 2013 for standing DWC committees.

The committee solicited nominations for ASC executive positions in Fall 2012 through the DWC listserv. Committee members were also asked for nominations. After compiling a list of potential candidates, we located vitas and forwarded the list and vitas to ASC.

The Constitution and Bylaws Committee has not be asked to engage in any committee work this year so far, though the members stand ready to respond if issues arise. The chair was consulted about several issues of language changes, as well as items missing from the Constitution that had been approved in previous years and were being used in practice. Updates were made to reflect changes that had been voted in on the past that had not been updated in the language of the document.

The outreach committee has been working to prepare the Division table for this year's conference. This year, this includes replacing all the DWC pamphlets and fliers, as well as creating a new committee sign up book. The committee is also working to replace the DWC ribbons with buttons. The committee had been coordinating the tasks of sending requests for individuals to sign up to work at the table, as well as working to coordinate the new member book raffle and will be soliciting books from division members to raffle off at the business meetings. These requests will be sent mid October.

E. Committee on Teaching and Pedagogy (formerly the Ad Hoc Syllabus and Curriculum Committee), CHAIRS: Kate Luther and Allison Foley

Since November of 2011, the Ad-Hoc Syllabus Collection Committee completed the Teaching Resources Collection for the division. We announced its completion and distributed it to the membership at the time of the 2011 Annual Meetings. Since that time, the committee discussed the future of the committee via email. Seeing that committee members have an ongoing interest

in and commitment to teaching and pedagogy, the committee petitioned the DWC Executive Council to take the committee off of temporary status. In doing so, we petitioned to remove the "Ad-Hoc" status from the committee's title and to rename the committee the Committee on Teaching and Pedagogy. This was approved at mid-year.

The committee then drafted a statement of purpose, goals, and methods and, in line with those goals and methods, successfully organized a series of roundtables for the 2012 Annual Meetings. They are "Gender Dynamics and Responding to the Challenging or Resistant Student," "Teaching Sensitive Topics: Intimate Partner Abuse, Rape, and Victim Blaming," and "Mentoring Undergraduates in Research and Scholarship." The committee also worked with Christina DeJong to get the Teaching Resources Collection hosted on the DWC website.

Description:

The Student Affairs Committee aims to encourage participation and career development, especially among students.

Current Project:

The Student Affairs Committee continues its Mentoring Program, which was initiated last year. An email soliciting participants was sent out on March 29th. We gained 12 mentors and 13 mentees, whom we matched based on professional and research interests. We will encourage mentoring pairs to meet at the Annual Meeting and to attend the DWC Social.

Future Projects:

We will continue the mentoring program and solicit new participants in March 2013. We plan to collect feedback from Mentoring Program participants regarding ways to develop effective mentoring relationships. We will distribute this information to current and potential participants.

We will start gathering information regarding various awards, grants, fellowships, and competitions to which DWC students may be interested in applying. We aim to compile a reference list for students and other DWC members.

We intend to put together a job-search focused roundtable session for the 2013 Annual Meeting.

During Spring 2012 the Student Paper Competition committee began advertising for the 2012 competition. Over the summer the competition announcement was posted numerous times to the DWC listserv and was advertised in the *Criminologist* as well. The advertisement was also posted to the Face Book pages for the DWC and the Victimology Section of the Academy of Criminal Justice Sciences. The committee also relied on their own scholarly networks to pass along information about the competition and encourage submissions. The Student Paper Competition received a record number of 25 submissions this year - 19 graduate and 6 undergraduate papers.

Each paper has been blindly assigned to 2 committee reviewers. Each committee member reviewed between 3-5 papers in total. Papers are being judged on the following merits based on a 1-10 scale, for a total value of 50 points (1 being the lowest; 10 being the highest): content is relevant to feminist scholarship; strong contribution to the knowledge base; accurately identify any research limitations; analytical plan well developed and clarity/ organization of paper. The paper with the highest average score will be deemed the winner in both categories (graduate and undergraduate). Scores are due to committee chairs by October 15th. The winners will be recognized at ASC and awarded cash prizes of \$500.00 to the winner of the graduate competition and \$250 to the winner of the undergraduate competition.

Nominations were solicited on September 17, 2012 by sending an announcement to all members who had paid their dues, as well as an email to the DWC listserv and DWC Facebook page. Candidates were nominated by others or self-nominated.

We are in the process of crafting a proposal for the editorial board to consider and a call for papers for the special edition. I anticipate a meeting with those we have volunteered to serve on this committee during the November ASC meetings to start firming up other plans. Since Joanne Belknap will be President during the 2014 ASC meetings, we believe we have a lot to celebrate! We have indeed come a long way!

J. Committee on Criminologists Working Outside of Academia, CHAIR: Becky Block Additional Members: Jennifer Colanese, Jennifer Truman, Deshonna Collier-Goubil, Jennifer Wareham, Monica Mendez, Amaia Iratzoqui

Criminologists who work outside of academia can face marginalization, disrespect, and invisibility not only because of their race, ethnicity or gender, but also because of their job. They may be ignored, feel unrepresented by groups such as the American Society of Criminology (ASC) or the Academy of Criminal Justice Sciences (ACJS), and have nowhere to go for mentorship and support. This situation has two kinds of negative consequences, for the criminologist and for the field. For the criminologist, it requires a special kind of courage to face disrespect from your peers, it can be frustrating to have important information to contribute to the field but to feel that your voice is not heard, and the unique difficulties you may face working in a public or nonprofit agency or a private organization are seldom addressed by the ASC. For criminology, the field becomes poorer when the perspective, experience and knowledge of those working outside of academia are not heard. As just one example, those whose job it is to take care of datasets and to help people to use data hold data integrity as perhaps their highest priority, and are an essential source of information about ways in which the ASC might work to increase data integrity. Mainstream academia, on the other hand, can find it convenient to ignore or gloss over threats to data integrity. By opening doors to collaboration between criminologists working in academic and nonacademic settings, the field is in a better position to address this and other extremely important issues.

Every year it seems that criminology has been paying more attention to the inclusion of criminologists working outside of academia, and to increasing the degree of "collaboration literacy" in the field. The committee on Criminological Careers Outside of Academia was established in 2004 in the Division on Women and Crime (DWC), although its membership and participants include people from throughout the ASC. The goals of the committee are the following:

- to further the support and mentoring of those who have made (or who want to make) a career in practice, research or policy outside of the traditional academic tenure-track system;
- to encourage the ASC to recognize contributions to the field made by criminologists working outside of academia;
- to encourage dissemination of practical research results to people who can apply the results to practice; and
- to provide a forum to discuss issues of data integrity, maintenance and archiving, and work to improve data quality and data availability.

At the suggestion of the committee, the DWC established in 2005 and first awarded in 2006 the Linda Saltzman Award for Contributions to Practice.

Although we are a committee within the Division of Women and Crime, we welcome as members and interested partners people within and outside of DWC. In particular, the Committee has reached out to other ASC Divisions, including the Division on People of Color and Crime, the Division on International Criminology, and the Division on Corrections and Sentencing. It has also reached out to agencies with a special focus on criminological practitioners, such as JRSA. Currently, there are fewer than 100 people on the Committee's Working Group listsery.

In 2012, the Committee focused on one of its key objectives—building a mentorship program to link criminologists who have built a career outside of academia with those who would like to know how to go about doing that, and with young professionals who need a place to go for advice. In this endeavor, we are working closely with the ASC mentoring program, guided by Bonnie Berry. Becky (Carolyn Rebecca) Block has joined the newly-formed Mentoring Committee of the ASC, which meets for the first time in November, 2012, discussed with Bonnie and others how to best fulfill the Committee on Criminological Careers Outside of Academia's goals while coordinating with the ASC, and wrote an article for the "Keys to Success" series that will appear in the Autumn edition of the Criminologist. Winners of the Saltzman Award were among the first to volunteer to serve as mentors. In addition to fostering long-term mentormentee relationships, we want to build other opportunities for the communication of knowledge about working outside of academia, such as an "Ask a Mentor" column on the DWC website. So far, committee members like these ideas; now we have to put them in action.

K. Special Events Committee, CHAIRS: Stacy Mallicoat and Amy D'Unger Additional Members: Jordana Navarro, Alesha Durfee, Jennifer Colanese

The primary duties of this committee continue to be planning for the social and business events of the Division on Women and Crime at the annual meetings of the American Society of Criminology. The DWC functions to be held at the 2012 annual meetings in Chicago include a social at an off-site location (The Gage Restaurant) and two breakfast business meetings. The first breakfast meeting will include an awards ceremony. The goals are to provide an opportunity for socializing and conducting business, minimize expenses, and have good food all at once.

This year's social is being held off-site at The Gage Restaurant, located at 24 S. Michigan Avenue. It is being hosted by the DWC, as the DPCC was not financially able to participate this year. Based on last year's ticket sales and the improved state of DWC budget in 2012 compared to 2011, we have allocated \$3,000 for the social. Costs for the event are below.

As in 2011, we have allocated approximately \$3,000 for both DWC breakfast meetings. Approximately 150 people purchased tickets for the social on Wednesday evening.

As with years past, the committee began circulation of the call for nominations in July. Each year we have four main avenues that we use to garner nominations. The committee members who volunteered for these tasks are as follows: Ruth Fleury-Steiner posted to the DWC website and the DWC Facebook page, Michelle Miller posted the call for nominations in *The*

Criminologist, Lisa Murphy posted to the ASC website, and Stacy Mallicoat posted the call on the DWC listserv.

In August, as co-chairs of the committee, Jennifer Colanese and myself (Carrie Buist) were concerned with the few nominations that we had received. It was at this time that we decided to email past winners and solicited nominations from them. This decision was quite helpful and did illicit several nominations. Stacy Mallicoat and myself also decided to begin posting the call for nominations to the DWC listserv weekly instead of bi-weekly.

The deadline for submissions was October 8th. This was decided based on the timeframe the committee had to get the call for nominations into *The Criminologist*. In total, the committee received nominations in 6 of the 7 categories. The category that did not have any nominees was Graduate Scholar. In the remaining 6 categories the committee received a total of 10 nominations. Two nominations for New Scholar, two nominations for Saltzman, two nominations for Distinguished Scholar, two nominations for the new Sarah Hall award, one nomination for Inconvenient Woman, and one nomination for Lifetime Achievement. In comparison to last year, we are down 3 nominations from 13 in 2011 to 10 in 2012.

Voting is scheduled to take place October 8th – October 11th. After the decisions have been made the information will be sent to Brenda Blackwell who has graciously helped the committee with ordering the plaques. It should be noted that the discount that Brenda has gotten in the past is substantial and therefore if for any reason we were to lose that connection, DWC should consider implementing a specified amount we are willing to reimburse for the purchase. Jennifer Colanese found that the least expensive plaques were \$50-\$60 dollars before engraving. Therefore with the potential of having 7 awards every year and in turn 7 plaques, this can be costly.

In addition, members of the committee will volunteer to write brief speeches for the award winners and present them with their awards at the DWC breakfast meeting. For the first time (to my knowledge) I have offered one of the individual's who made a nomination the opportunity to introduce the Lifetime Achievement Award because if awarded, it will be given posthumously.

All award winners will be contacted and encouraged to attend the event.

III. Activities of the Executive Committee

The Executive Committee (EC) of the DWC was very busy in 2011 – 2012. Following is a list of the activities and accomplishments of the Executive Committee in the past year.

- Assisted the Outreach Committee with the creation of new promotional materials for the DWC, including a new brochure and banner and the design of a new logo.
- Created a new mechanism for online donations to the DWC general operating fund and
 the new DWC "Future Fund." The intent of the Future Fund is to create a source of
 funding to support programs and projects aimed at advancing the mission of the Division
 on Women and Crime. The EC will make decisions regarding how the fund may be
 spent. Examples might include support for graduate students to travel to the ASC
 annual meeting, workshops or special sessions before/during the ASC meeting, small
 seed grants to help with the initiation of innovative research projects, etc.
- Updated the renewal process for DWC, so members can now renew for three years
 when they renew their ASC membership for three years. This alleviates the issue of
 members who renewed their ASC membership for three years, but then forgot to
 annually renew their DWC membership.
- Created an online member directory with areas of expertise, to be updated 1 2 times
 per year by the Secretary/Treasurer and the Website Committee. The URL for the
 directory is http://ascdwc.com/member-directory.
- Created a "Resources" section of the DWC online newsletter to permanently archive syllabi, movie lists, websites, and other resources that might aid members in their research and teaching. Many of the items come from discussions on the DWC listserv. The URL for the newsletter is www.hts.gatech.edu/dwc. Click on the link to the left that says "Resources."
- Created a session at the ASC meeting in honor of DWC member Roslyn Muraskin, who
 recently passed away. The session honors her legacy as a scholar, mentor, teacher,
 and advocate.
- In the process of creating a profit-sharing agreement with the editor and editorial board
 of the DWC's journal, Feminist Criminology, whereby some portion of profits made by
 the journal would be shifted to the DWC account.
- Updated language in the DWC Constitution to reflect changes made in recent years.

IV. New Business

A significant amount of new business was conducted at the American Society of Criminology meeting. Awards were given to the following individuals:

Following is a summary of the work of the Executive Board (EB) and general membership at the meeting:

- The Website Committee was renamed the Social Media Committee.
- The EB agreed to do a survey of DWC members on a variety of topics, including social
 media usage, needs of the members, programming at ASC meetings, committee work,
 etc. A breakout discussion on the survey was held at the Friday breakfast meeting, with
 suggestions for the survey submitted to Secretary/Treasurer Christina DeJong.
- The EB discussed possible activities for the 30th anniversary celebration in 2014, including a list of potential keynote speakers. Supreme Court Justice Sonia Sotomayor has already been asked to speak and we are awaiting her response. A special edition of *Feminist Criminology* will be released in October 2014, with a due date of April 2013 for submissions.
- The EB and the membership discussed the creation of an elected Graduate Student Representative to the DWC Executive Board position. A general proposal for amending the DWC constitution to add such a position was discussed at the Executive Board meeting, while more discussion ensued at the Friday business meeting. The discussion will move online via the DWC listserv and then a formal amendment to the constitution will be drafted and put forth for a vote.
- The EB agreed to explore a possible restructuring of elections, via either an extension of
 officers' terms to three years or the addition of a chair-elect position. The logistics were
 initially discussed at the EB meeting, with an agreement to look into how other
 organizations structure their offices and elections in order to provide some guidance on
 DWC restructuring.
- A revenue-sharing agreement was made between the Executive Board of the DWC and the Editorial Board of *Feminist Criminology*. Because of the robust nature of the revenues generated by *Feminist Criminology*, the Editorial Board voted to share some profit with the DWC. Funds will be provided to the DWC in two ways. First, the journal will fund the cost of the two student paper awards (\$500 for the graduate winner and \$250 for the undergraduate winner) and the plaques given to all award winners (approximately \$300 total per year). Second, the journal will contribute 10% of royalties each year, as long as the royalties remain above \$5,000 per year. If they drop below \$5,000 per year, the fund transfer will stop.
- Breakout discussions were held at the Friday business meeting on the following topics:
 - Survey of members
 - 30th anniversary committee
 - Mentoring
